Dwellings not billed via the County property tax bill will be billed directly by Contractor, quarterly in advance.</p> <p>(2) Single family rate applies to dwellings in mobile home parks that are direct billed individually by Contractor.</p> <p>(3) Containers (carts & bins) must be no more than level full with lids closed. C&D waste and animal waste prohibited, except for animal waste for household pets.</p> <p>(4) Detached single family service billed on County property tax bill.
